DIRECTIONS FOR USE:

Restraints: for RUMINANTS ONLY - Copper @ 6.5g/L
DO NOT administer at the same time with other preparations that contain Selenium or COPPER;
DO NOT administer if grazing pasture contains plants known to have a high Copper content;

WHEN IN DOUBT - Consult your local veterinary clinic.

PRECAUTIONS: Recommended doses must not be exceeded.

Ensure animals have access to water.

Avoid stress to young or weak animals.

GENERAL DIRECTIONS: Check drenching gun for accuracy before & during use. Ensure always a smooth drenching nozzle. Thoroughly rinse all drenching equipment after use

SAFETY DIRECTIONS: Harmful if swallowed. Will irritate the eyes, nose, throat & skin. Avoid contact with the eyes & skin. Wash hands after using.

FIRST AID INSTRUCTIONS: If swallowed **DO NOT INDUCE VOMITING.** Call a doctor or the **Poisons Information Centre, (Phone Australia 131 126)** and give activated charcoal if instructed. Rinse mouth out with water. If product is in the eyes, hold eyes wide open and flood with water for at least 15 minutes. See a doctor.

STORAGE: Store below 30°C (room temperature) in original container.

DISPOSAL: Triple or pressure rinse container. Dispose of all rinse liquid according to State Legislative requirements. Crush or puncture the empty container and bury in an authorised landfill. Do not burn empty container or product.
